ABSTRACT

The objective of this research was aimed to study the level of The People's Opinion, to compare the opinion of the people classified by gender age and relationship with the village headman and suggestions The performance of the role of headman of the people in the area YodChad Sub-district, Wangyang District, Nakhonphanom Province. The sample was the people 371 persons, selected by Taro Yamane's Technique selected through simple random sampling method. The data were collected by a questionnaire with 0.689-0.809 discrimination indices and a .98 reliability. The statistics used were frequency, percentage, mean, standard deviation, t-test and One Way ANOVA (F-test) was employed for hypothesis testing at the .05 level.

The study opinions of people toward the role of the Village Headman in the area Yodchad Sub-district, Wangyang District, Nakhonphanom Province. The results were as follows:

1. Level of opinions of people toward the role of the Village Headman in the area Yodchad Sub-district, Wangyang District, Nakhonphanom Province total offense. Overall is moderate ($\bar{X} = 3.05$, S.D. = 1.11) when considering the order of most to least include the representation of ($\bar{X} = 3.08$, S.D. = 1.10), followed by the representatives of the government ($\bar{X} = 3.05$, S.D. = 1.10) and the Community leadership ($\bar{X} = 3.03$, S.D. = 1.13)

2. Comparison of opinions of people toward the role of the Village Headman in the area Yodchad Sub-district, Wangyang District, Nakhonphanom Province by sex in general is no different. When considering each found the official representative the difference is statistically significant at the .05 level. Then no different.

3. Comparison of opinions of people toward the role of the Village Headman in the area

Yodchad Sub-district, Wangyang District, Nakhonphanom Province by age overall no difference. But considering that aspect. The official representative of the difference was statistically significant at the .05 level.

4.
